PROOF FOR FULL TIME COLLEGE STUDENTS (UNDER THE AGE OF 22 YEARS OLD) LIVING at HOME MUST BE INCLUDED WITH MEMBERSHIP FORM. Proof of college status can be the acceptance letter from the college for that school year/semester or the semester bill/invoice for your child. We cannot accept a copy of their school photo I.D. as proof of school status.

Discounted Guest Passes will be available to members at the Recreation Office throughout the season. **Each membership is limited to 15 guest passes.** Pre-purchased Guest Passes maybe picked up beginning May 4, 2020 at the Recreation Office. Guest passes are not available for pick up at the WaterWorks pool. The Recreation Office is open Monday through Friday, 9:00 am to 5:00 pm.

PLEASE NOTE: NO refunds will be issued on Membership Fees or Guest Passes after May 8th.

NON-RESIDENT Membership Types & Fees

FAMILY MEMBERSHIP: Early registration \$575.00 (AFTER April 24th \$650.00)

The Family Membership includes members of the same family unit residing at the same address. A family unit is defined as one or both parents, legal guardians, children under the age of 18, and full time students under the age of 22. Children can be natural, adopted, foster or any minor child/children for which the parents or guardians have legal custody.

* Childcare providers, live-in helpers and grandparents do not qualify under family membership. They may qualify to join under individual membership if they reside at the same address.

INDIVIDUAL MEMBERSHIP: Early Registration \$275.00 (AFTER April 24th \$325.00)

Any resident between the ages of 2 and 61 as of May 23rd may apply for Individual Membership. Live-in helpers, child care providers and live-in grandparents are eligible for Individual Membership. *If any individual under the age of 18 is applying for Individual Membership, their parent or legal guardian must also be a member.

SENIOR MEMBERSHIP: Early Registration \$170.00 (AFTER April 24th \$220.00)

Any resident, 62 years of age or older, is eligible for Senior Membership.

PARENT/CHILD MEMBERSHIP: Early Registration \$375.00 (AFTER April 24th \$425.00)

The Parent/Child Membership includes 1 parent and 1 child of the same family unit residing at the same address. One (and only one) parent or legal guardian and the child must be under the age of 18. The child can be natural, adopted, foster or any minor child for which the parent or guardian has legal custody.

* Childcare providers, live-in helpers and grandparents do not qualify as parents.
